2020 Grant Renewals:

Tri-Valley Developmental Services, Inc. – Tri-Valley will renew their grant; current expenditures \$7,334. Schroeder will follow up on Monday.

University of Missouri - Ad Hoc Committee (Heiman, Keck, McLemore, Seitz, Smith) will schedule a meeting UMKC to have a conversation about future activities/actions.

Families Together, Inc. – (PIEP) The Parent IEP Mentor Project have accepted renewal for 66,195.

Families Together, Inc. - (FEAT) Family Employment Awareness Training have accepted renewal for \$25,000.

Central KS Community Foundation dba Employment First Butler Cty
Butler County has accepted renewal. Discussions between Butler County
and DCF concerning their off year will be figured out shortly.

Johnson County Developmental Supports - JCDS has plans to spend the full \$23,000 this year, and next year will need approximately \$10,000.

Kansas Youth Empowerment Academy (KYEA) Youth Leadership – KYEA accepted renewal of \$15,000 for 2020.

Kansas Youth Empowerment Academy (KYEA) Faces of Change -

New Faces class now has 10 participants. KYEA have currently spent \$4,828 out of \$15,000. Fairchild made a motion to allow KYEA to carry funds forward into renewal grant period and to renew grant for 2020 (KCDD will work with DCF to assure funding whether through renewal or no cost extension. Swindler second. Motion pass. Smith abstain.

Advocacy in Motion, Inc. – Swindler made a motion **NOT TO RENEW** the AIM grant. Bowles second. Motion pass.

Wichita State University - Bowles made a motion **NOT TO RENEW** the WSU grant. Fairchild second. Motion pass.

Self-Advocate Coalition of Kansas (SACK) Extension – Fairchild made a motion to not renew funding for SACK. No second.

Meitner made a motion to renew current grant/contract for (\$50,000) contingent upon quarterly reports providing more clarity on outcomes and budget line items. Seitz second. Motion pass. McLemore abstain. Swindler abstain (out of room).

Sunflower Diversified Services – Bowles made a motion to approve Disability Mentoring Day (DMD) Unsolicited Project Application for \$1,000. Seitz second. Motion pass.

2020 Employment First Conference - Swindler made a motion to approve \$50,000 for obligating funds for the Employment First Summit. Fairchild and Story second. Motion pass.

The extension gives states until March 2022 to fully implement transition plans and achieve compliance with the HCBS Settings Final Rule.
